### **Black Gay Weddings Feature Submission Policy**

Effective Date: January 1, 2025

### **Eligibility Requirements:**

#### 1. Premium Subscription Requirement

• To submit a feature, you must be an **Instagram premium subscriber** to <u>Black Gay Weddings</u> or a BGW Elevate Paid subscriber. Premium subscriptions can be activated for \$2.99/month through our Instagram page.

## 2. Photographer and Videographer Releases

- All submitted photos and videos must have a signed **Photo/Video Release Form** from the photographer and/or videographer granting Black Gay

  Weddings the rights to use their work across our platforms (website, social media, magazine, etc.).
- Releases may be completed at the following link: <u>BMG Media Release</u>
  The photographer/videographer must complete release(s) **before** submitting your feature.

#### 3. Content Criteria

- Submissions must reflect authentic love stories, celebrations, and milestones from LGBTQIA+ couples of color.
- Content must align with our values of diversity, representation, and inclusion.
- We welcome weddings, engagements, anniversaries, commitment ceremonies, and community news/Interest stories.

#### 4. File Requirements

- Photos: High-resolution JPEG or PNG files only.
- Videos: MP4 format, no longer than 5 minutes in length.
- Submissions must include captions with vendor credits and a brief description of the event/story. NOTE: Other than videographers and photographers, If vendors are not members of the LGBTQBizList, **they will not** be mentioned in the feature.

#### **Our Submission Process:**

## 1. Step 1: Subscription Verification

• Confirm your **Instagram premium subscriber status** by uploading a screenshot of your active subscription.

#### 2. Step 2: Complete Online Submission Form

• Visit our <u>BGW Submission Form</u> on our website, using the Instagram link in bio to complete the form.

### 3. Step 3: Upload Required Documents and Media

Attach high-resolution photos/videos.

#### 4. Step 4: Pay Express Submission Fee

• While basic submissions are included with the premium subscription, expedited reviews are available for a **\$25 rush fee** to prioritize review within 7 business days.

## 5. Step 5: Confirmation Email

After submission, you will receive an email confirmation

### **Our Review and Approval Process:**

# 1. Initial Screening (3-5 Business Days)

• Submissions are reviewed for completeness, eligibility, and alignment with our guidelines.

#### 2. Editorial Review (7–10 Business Days)

Our team evaluates content for quality, storytelling, and representation.

### 3. Final Approval and Scheduling

- Approved features are scheduled for publication based on editorial timelines.
- Contributors will receive a release date notification via email.

### 4. Revisions or Rejections

- If revisions are needed, submitters will be notified with specific feedback.
- Rejected submissions will receive no further actions.

### **Rights and Usage Agreement**

- By submitting, you grant Black Gay Weddings the **non-exclusive rights** to publish and promote your content across our platforms.
- You acknowledge that submitted materials may be edited for clarity, formatting, and promotional purposes.
- Black Gay Weddings reserves the right to decline any submission that does not meet quality or content standards.
